- **NEOH WG UPDATES:**
 - **WG1: HANDBOOK DEVELOPMENT**
 - WG1 members are putting together a lot of effort into the development of the first draft of the handbook. All chapter leaders have reported their progress to the WG1 leaders and most chapters are advancing at a good pace in preparation for the meeting in Lisbon.
 - **WG2: SELECTION OF CASE STUDIES; SURVEY ON ONE HEALTH STATUS IN PARTNER COUNTRIES:**
 - WG2 is working on a survey that enquires about the One Health status in every country with the aim to publish the results. The questions to be covered can be found in the WG2 folder on Alfresco

 - WG2 is discussing the suitability of case studies to apply the NEOH handbook in a next phase.
 - **WG3: LITERATURE REVIEW**
 - To our great regret, Prof. **Chinwe Ifeijka Speranza** had to step back from her MC position for Germany because of moving to Switzerland. She will continue to be an active member of the network, but cannot lead anymore due to her change in MC status. Therefore, we are looking for a new co-leader for WG3. **If you are interested and/or would like to suggest somebody for this role, please do get in touch with Barbara Haesler.**
 - WG3 members are planning a literature review on evaluation of One Health initiatives to include them in a meta-analysis. If you are aware of evaluations of One Health, please get in touch with Vladimir Grosbois.
 - **WG4: PLANNING OF A STAKEHOLDER MEETING AND ESTABLISHMENT OF AN ADVISORY PANEL:**
 - WG4 members were very successful in planning a stakeholder meeting in Brussels with good representation from different stakeholder organisations – see the attached programme. Unfortunately, the meeting had to be postponed due to the security situation in Brussels.

 - **Poster prize!** A NEOH poster by **Marilena Filippitzi** (Ghent University, Belgium), Luís Pedro Carmo (University of Bern, Switzerland), Daniele De Meneghi (University of Turin, Italy), Liza Rosenbaum Nielsen (University of Copenhagen, Denmark) and Barbara Häsler on “Transdisciplinary collaboration across Europe to promote Global Health: Network for Evaluation of One Health (NEOH)” won the first prize in the poster competition at the Annual Scientific Conference of the European College of Veterinary Public Health (ECVPH) in October 2015 in Belgrade, Serbia.

- A NEOH **poster** was presented by **Ann Lindberg** et al. at the conference of the International Society for Veterinary Epidemiology and Economics (ISVEE) in Merida, Mexico (November 2015). Laura Falzon (Veterinary Public Health Institute, Switzerland) gave a presentation on the ECVPH residents research project on systematic literature review on OH; she quoted and acknowledged the collaboration with NEOH and created a wonderful opportunity for Barbara Haesler to make people aware of the network.
- **Karin Artursson** (National Veterinary Institute, Sweden) et al. presented a **NEOH poster** and **Barbara Haesler** introduced NEOH in her **talk** “Assessing the benefits of One Health approaches” at the MedVetNet Association scientific conference “Global Challenges in foodborne zoonoses: combating emerging threats using a One-Health approach”, Paris, France (October 2015).
- **Ann Lindberg** (National Veterinary Institute, Sweden) et al. attended a workshop in Hanoi (August 2015) under the framework of the US initiative “The Global Health Security Agenda” (GHSA, <http://www.cdc.gov/globalhealth/security/index.htm>), focusing on GHSA’s action package on zoonotic diseases (ZDAP, http://www.cdc.gov/globalhealth/security/actionpackages/zoonotic_disease.htm). NEOH was represented through the Swedish delegates, and **leaflets** reportedly disappeared like “butter in sunshine” (Swedish expression)...
- **Abstracts** have been submitted for the 26th European Congress of Clinical Microbiology and Infectious Diseases (pending - John Rossen et al.) and the ESOF conference 2016 in Manchester – UK (pending – Haesler et al).

 - **Manuscript:** Barry McMahon (University College Dublin, Ireland), Simon Ruegg (University of Zurich, Switzerland), and Ann Lindberg (National Veterinary Institute, Sweden) are leading the preparation of a manuscript on “What makes One Health One Health” illustrating and discussing the outcomes of the workshop in Cluj.
 - **Manuscript:** David Adamson (U o Queensland, Australia) is working on a manuscript on “Decision Making and One-Health: What can we learn from IPM?” (Abstract: A key realisation in the development of an economist is that the tools and techniques learnt can generally be applied to all problems. By extrapolating from that step this paper debates that the economic foundations of one-health are identical to the economics of integrated pest management

(IPM). If this argument holds true, then the rules applicable to IPM are equally applicable to One-Health. This linkage of concepts then provides practitioners of One-Health with access to a new source of detailed historical literature identifying both the positives and negatives associated with the adoption, adaptation and evolution of IPM. These findings then may provide One-Health decision makers from stumbling into the same errors as the development of IPM policy).

- **Manuscript:** Roberto Esposito (Italian Institute of Health) is leading work on a publication on One Health governance

- The third call for applications with a particular focus on inclusiveness countries was published in October 2015
- Luís Pedro Carmo (Veterinary Public Health Institute, Switzerland) has successfully completed a STSM at the University of Copenhagen, Denmark
- Laura Falzon (Veterinary Public Health Institute, Switzerland) did a STSM at the Royal Veterinary College, United Kingdom
- Applications have been pre-approved for Soledad Cuevas (London School of Hygiene and Tropical Medicine) for a STSM at Università di Bologna, Italy; for Maria Eleni Filippitzi at Agence française de développement (AFD), Paris (FR) and for Elena Boriani at University of Zurich (CH). One application was rejected.

• NEWS FROM COST:

- Due to the shift to H2020 and the need to align COST finance reporting with the H2020 reporting structures, instead of having a single two year grant period from 01-01-2015 to 31-12-2016, we now have **three grant periods**, namely:
 - GP1 (ended): 01-01-2015 to 30-09-2015
 - GP2 (running): 01-10-2015 to 30-04-2015
 - GP3 (tbc): 01-05-2015 – will run for either 8 or 12 months – still to be decided by COSTThis does not have any implications on the budget available, but requires more admin work, in particular from the grant manager (Houda Bennani) and the grant holder (RVC).
- Over the summer and autumn months, Houda Bennani (grant manager), Barbara Haesler and staff working for the grant holder (RVC) in the financial and research offices put in a lot of effort to put together all the documentation needed for the **first financial report**, which has been **approved** by the COST office.
