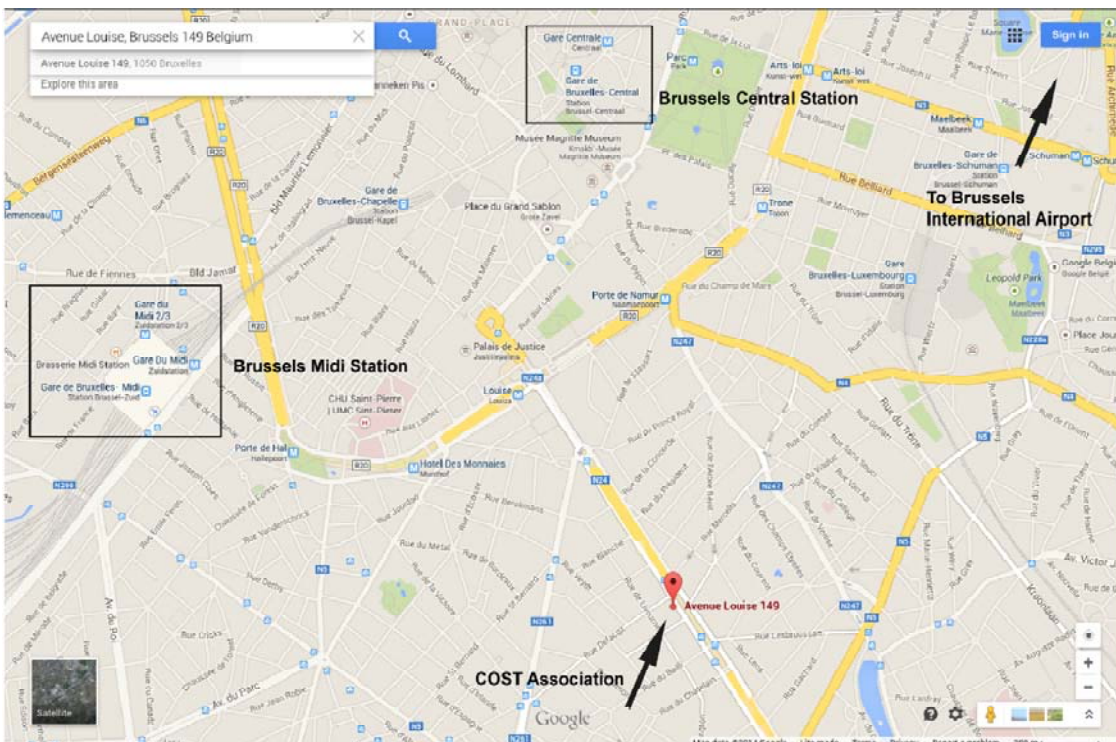
Network for Evaluation of One Health (NEOH) stakeholder meeting

Aims of the meeting

The general aim of the meeting will be to establish links between the Network for Evaluation of One Health (NEOH) consortium members and stakeholders from existing national and international platforms with an interest in One Health initiatives and evaluation of One Health or other interdisciplinary health endeavours. The meeting will be used to introduce the NEOH and present the outcomes of Working Group 1 to date as well as intended Action activities and expected outcomes. Stakeholders will be invited to reflect on these outcomes, and together with consortium members will identify and discuss potential gaps in the proposed evaluation protocol and differences in perceptions about how One Health evaluation can be of value.

Moreover, participants will be asked for their views on and willingness to participate in the following activities:

1. Dissemination of information about the activities of the network and its achievements to relevant stakeholders and networks.
2. Communication strategy with relevant stakeholders throughout the lifetime of the network.
3. Generating a policy advice scheme for implementation of evaluation protocol for One Health initiatives.
4. Stakeholder participation in training schools and the final NEOH conference.

Based on the outcomes of the workshop, the NEOH consortium will provide a report which will identify potential activities relevant for achieving and improving the aims of the Action.

Expected outcomes

The engagement of stakeholders will be a critical activity throughout the lifetime of the Action. The development of a **policy advice scheme** is envisaged to give direction on strategic activities in the evaluation of One Health, target users and how the evaluation protocol can add value to decision-making. Stakeholders will be asked to provide feedback on the scheme to make sure that their interests and demands are well-reflected and considered during the establishment of the protocol. They will be asked to provide scientific, practical, pragmatic and useable advice on how the proposed evaluation protocol can be useful for stakeholders.

During the final NEOH conference stakeholders will be invited to join a plenary discussion session. This session with participation of international institutions will be used to present and discuss the policy advice scheme and provide guidance on the evaluation protocol.
