1. Purpose of the visit

The aim of the short term scientific mission at the Royal Veterinary College was to assist Prof. R.Kock, lead author of Chapter 2 of the NEOH handbook, in the consolidating and referencing of examples and general justification for implementing a One Health approach in the context of the newly established SDGs , to meet NEOH scientists and familiarize myself with WG1's mission and methodology during the Copenhagen workshop. My current work interest is focusing on validating a practical model for implementing One Health programmes with a gender perspective in developing countries around conservation areas, so meeting NEOH scientists and learning about the conceptual framework for developing and implementing One Health was going to be beneficial

2. Description of the work carried out

The work was carrried out through the collection and analysis of recent available literature on One Health, on EU different environmental and health policies and trends, on assessments of the SDGs, as well as on some biodiversity trends in Europe. This was achieved by frequenting the library of the Royal Veterinary College andby doing some literature search on the web.





Work on Chapter 2 of the Handbook included updating the literature review, consolidating the analysis by bringing in elements of biodiversity conservation and developing the Agenda 2030 for Sustainable Development within a European context.

Familiarization process with NEOH methods for developing Chapter 2 was undertaken at the Copenhagen Workshop on 20th and 21st April.

3. Description of the main results obtained

Work on Chapter 2 of the Handbook included:

- Updating of the literature review with inclusion of more than 50 new references in the chapter
- Editing and reformating the chapter to make it more suitable for publication
- Writing up the Methods section
- Bringing in elements of biodiversity conservation in some of the examples described in relation with the SDGs
- Developing the concept of synergies and trade-offs that exist between SDGs within the context of the Agenda 2030 for Sustainable Development in the discussion as illustrated by Fig.10
- Writing up the conclusion

4. Future collaboration with host institution (if applicable)

The possibility of linking up student's projects as part of the One Health MSc Course with projects currently being developed by the Odyssey Conservation Trust were discussed with Prof. R.Kock.

5. Projected publications resulting or anticipated to result from the STSM

Discussions for the submission of Ch.2 for publication were also undertaken with R. Kock and B.Haesler and the following 4 journals were considered for publication:

- Health Systems
- J. Public Health Policy
- Social Theory & Health
- Social Science & Medicine

It was agreed that Social Science & Medicine would be the first publication to consider.

6. Confirmation by the host of the successful execution of the mission

Dr Julie Garnier successfully completed her STSM attachment including attendance at the Royal Veterinary College London and at the Copenhagen NEOH meeting where she actively contributed to the community discussion and meeting agenda. Whilst at the RVC she worked with me and other colleagues working in NEOH to bring the chapter 2 of the manual to an advanced stage and she did this work effectively and competently.
