- One Health intuitively appealing

What's lacking

- Not mainstream (yet)
- No systematic resource allocation

What's needed

- **Standardised methods, approaches and data to evaluate One Health activities**
- Robust evidence basis for informed decision-making and resource allocation

NEOH's aim

What's needed

- **Standardised methods, approaches and data to evaluate One Health activities**
- Robust evidence-based tools for informed decision-making and resource allocation

“To enable future quantitative evaluations of One Health activities and developing and applying a science-based evaluation protocol in a community of experts”

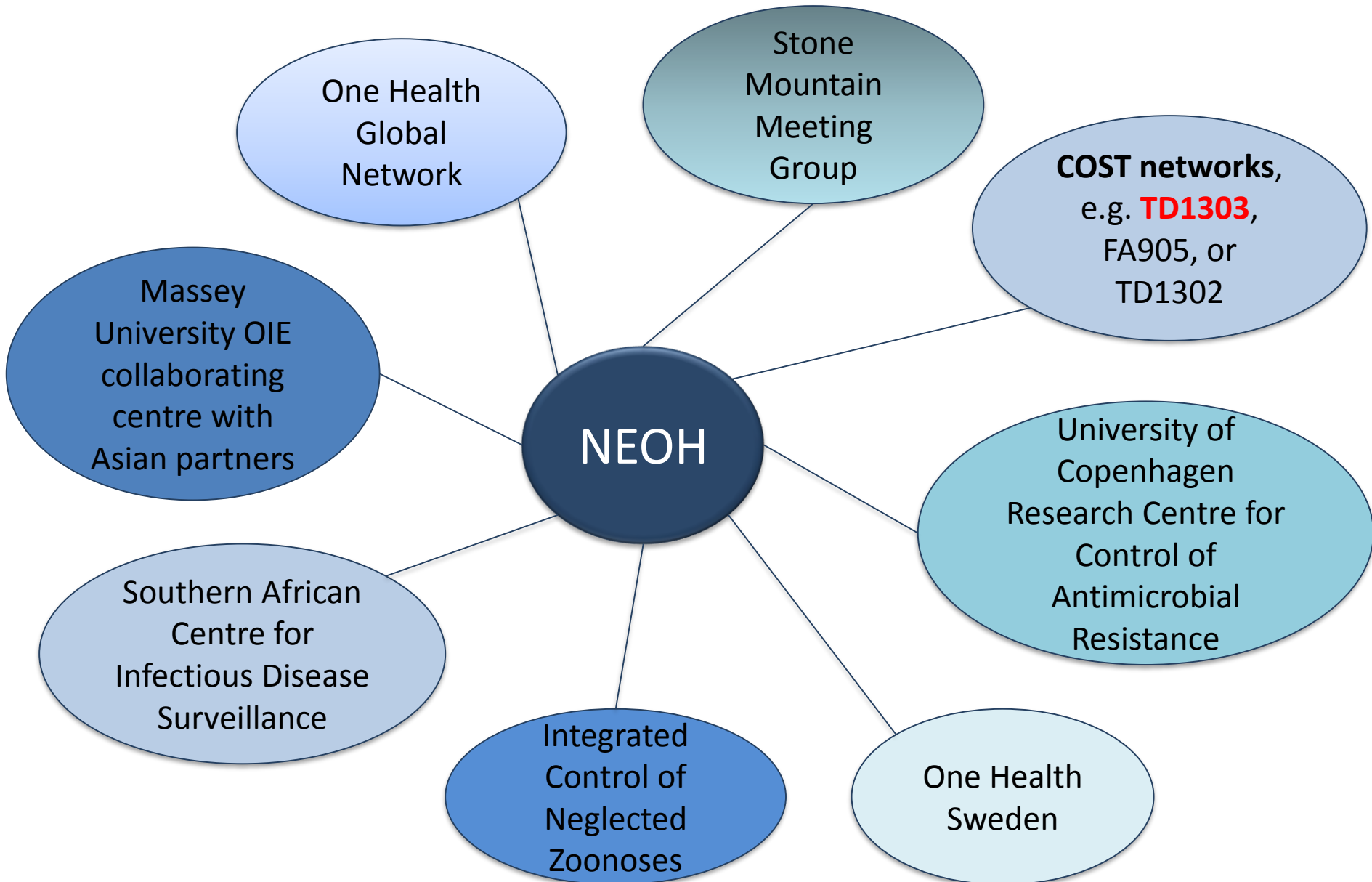
In short: To develop and use methods and frameworks for improved One Health decision making

- 1. Creating the necessary evidence basis to enable informed decision-making and resource allocation** / Input to stakeholders (WG1-WG4)
- 2. Evaluation of One Health initiatives (case studies)** / Comparison and/or performance assessment of theory/ model/ scenario/ projection/ simulation/ narrative/ methodology/ technology/ technique (WG2 and WG3)
- 3. Development of evaluation framework for One Health** / Development of knowledge needing international coordination: new or improved theory/ model/ scenario/ projection/ simulation/ narrative/methodology/technology/technique (WG1)
- 4. Interdisciplinary collaboration to tackle complex global challenges** / Bridging separate fields of science/disciplines to achieve breakthroughs that require an interdisciplinary approach (WG1-WG4)

expected/suggested contributors → EurNegVec **MC** and/or **MC substitutes** of those COST countries which do not (yet) have MC representatives in NEOH (a [country list](#)/participants' mailing list being provided);

for a representative survey → **answers from each COST Country**, min. **9 respondents** (3x3 quest. response method)

at least 1 respondent for each of the 3 OH “pillars/components”:

- 1. Animal Health (AH);**
- 2. Human Health/Public Health (HH/PH);**
- 3. Environmental Health (EH).**

- **1 x 3 respondents** from the **public institutions/ministries**:

- i.) **1** for **AH** “pillar”, e.g. head/senior person of **Veterinary Services – MoA**;
- ii.) **1** for **HH/PH** “pillar”, e.g. head/senior person of **HH/PH services - MoH**);
- iii.) **1** for **EH** “pillar”, e.g. head/senior person of **EH services – MoE**)

- **1 x 3 respondents** from the **academia/research**:

- i.) **1** for **AH** “pillar”, e.g. head of the Board of Directors of the Veterinary Faculties;
- ii.) **1** for **HH/PH** “pillar”, e.g. head/director of the Board of Directors of each country’s HH/PH faculties;
- iii.) **1** for **EH** “pillar”, e.g. head/director of the Board of Directors of each country’s Environmental Sciences faculties.

- **1x 3 respondents** from the **private sector/NGOs**:

- i.) **1** for **AH** “pillar”, e.g. head of the National Council/Board of Veterinarians;
- ii.) **1** for **HH/PH** “pillar”, e.g. head of the National Council/Board of Family Doctors, or Public Health nurses, etc.;
- iii.) **1** for **EH** “pillar”, e.g. head of the National Council/Board of the Environmental Sciences Specialists)

Additional respondents: head/director of National association for consumers’ protection; of National Society for Wildlife/Environmental Conservation; Agronomist/Veterinarians without Borders; *Medecins sans Frontieres*; etc.
